INSTRUCTION TO TENDERERS

Sealed tenders in two cover system are invited by General Manager, Tamil Nadu Minerals Limited, 31, Kamarajar Salai, Chepauk, Chennai - 600 005 for the purchase of polished black and colour granite 10mm & 12mm tiles produced from granite blocks of TAMIN, from its factory at TAMIN Granites Tile Plant, Madhepalli (100% Export Oriented Unit), Krishnagiri Taluk and District, Tamil Nadu.

CONDITIONS:

1(a) Eligibility to participate:

- i. Buyers from foreign countries
- ii. Indian buyer only under third party exports basis. The proof of having RBI Code number or Export and Import code number should be furnished along with the tender, Since the sale is from 100% EOU Unit of TAMIN.
- iii. EOUs with valid license period

1(b) The following categories will not be eligible to participate in the tender:

- i. Buyers who came to adverse notice in dealing with TAMIN.
- ii. Those who have indulged in malfeasance during the course of their business transactions with TAMIN.

2. Location of TAMIN Granite Tiles Plant, Madhepalli:

TAMIN Granites Tile Plant is located at 406, Kanimedu, Madhepalli Village, Kanthikuppam Post, Krishnagiri Taluk, Krishnagiri District, Tamil Nadu.

3. Specimen of Samples:

The Polished samples of tiles variety of black and colour for sale are displayed for inspection at the Registered Office of TAMIN at 31, Kamarajar Salai, Chepauk, Chennai 600 005 and on any working days during working hours.

4. Tender Submission:

Tenders should be submitted as per clause 13(A) under two cover system superscribed "TENDERS FOR THE SALE OF BLACK AND COLOUR GRANITE 10mm & 12mm TILES " and sent by Registered post or by special messenger so as to reach the General Manager, Tamil Nadu Minerals Limited, 31 Kamarajar Salai, Chepauk, Chennai-600 005 on or before 2.00 PM on 18.12.2017.

5. Delays in Transit:

Tender documents received after the due date and time either by post or by courier or by hand delivery or by any other mode, shall not be accepted by TAMIN. TAMIN is not responsible for any delay in transit for delivery of the tender documents.

6. Opening:

The tenders will be opened at the Registered Office of the Corporation by the Managing Director or by any authorized Committee in the presence of the tenderers or their authorized persons, if any as noted below:

- i. The cover-I containing the E.M.D. and other details will be opened at 3.00 pm on 18.12.2017
- ii. The date of opening of the cover- II containing the Price Bid of the eligible tenderers, will be communicated separately. For further details please refer clause 13(A)

7. Formats:

All tenders price bid (Cover –II) should be submitted only in the prescribed form in Annexure-3. The Status background of the tenderer should also be furnished in the format available in Annexure-2 (Cover I).

8. Quotations:

- i. The Foreign tenderers are requested to quote the rate in US Dollar per Sq.ft on FOB Chennai basis as in Annexure – 3. Those who quote in U.S.Dollars should pay only in U.S.Dollars.
- ii. The Indian tenderers are requested to quote the rate in Indian Rupee per Sqft on
 - a. Ex-Factory (without packing, transport, clearing and forwarding charges etc.) as in Annexure – 3 or
 - b. FOB Chennai Port, which is inclusive of packing, transport, clearing and forwarding etc. as in Annexure – 3. The port may be specifically mentioned.
- iii. Sizes and specification of black and colour granites tiles are furnished in clause 11. The rate should be quoted separately for black and colour material of granite 10mm & 12mm tiles produced from the quarries as per the Annexure–1. Quotations shall specify the amount both in figures and words and rates shall not be altered. The tenderer can quote separate rates for different sizes of black and colour granite tiles without insisting percentage of any specific size of tiles.

- iv. There is only single quality for both black & colour granite 10mm & 12mm tiles produced from each quarry material as per the quarries list in Annexure-I
- v. Rates should be quoted per Sq.ft. only.

9. Period of Agreement:

The successful tenderers will enter into an agreement with TAMIN and the period of validity of the agreement will be one year. TAMIN reserves the right to extend the period of validity of the agreement for further period at the end of one year.

10. Quantity to be Supplied:

Supply will be made by TAMIN to the successful tenderers' assured quantity as mentioned in the Sl.No. 9 of Annexure - 2 during the period as per the condition in Sl.No.9 as above.

11. Specification:

TAMIN will supply the following size & thickness of export worthy polished granite tiles, as detailed below:

- 1) 305mm x 305mm x 10mm
- 2) 610mm x 305 mm x 10mm
- 3) 305mm x 305mm x 12mm
- 4) 400mm x 400mm x 12mm
- 5) 457.2mm x 457.2mm x 12mm
- 6) 600mm x 400mm x 12mm
- 7) 457.2mm x 305mm x 10mm
- 8) 457.2mm x 305mm x 12mm

The entire processing will be done by water cutting, calibration, line polishing, multi disc tile cutting, chamfering etc.,

12. Payment:

i) Foreign Buyer::

The successful foreign tenderer should make advance payment through FIRC (Foreign inward Remittance Certificate) against proforma invoice in favour of Tamil Nadu Minerals Limited, Chennai through State Bank of India, PWD Complex, Chepauk, Chennai -05 to facilitate the shipment of all the approved tiles.

ii) Inland Buyers:

The Indian Buyers should remit the sale value for the granite tiles within one week from the date of selection by Demand Draft / RTGS / NEFT drawn on any scheduled Bank in favour of Tamil Nadu Minerals Limited, Chennai. He shall arrange to remove the tiles within a reasonable time after making payment, and if any instruction is issued to remove the same without any delay, the buyer shall obey it promptly.

iii) No complaint of any nature can be entertained after the selection of tiles by the buyer and such tiles are at the risk of the buyer.

13. A) Quotation-Two Cover System:

The tender should be submitted in 2-cover system viz.

- i. **Cover- I:** Technical bid: It shall contain
 - a. E.M.D. of Rs.50,000/- (Rupees Fifty Thousand only) / equivalent in US Dollar by Demand Draft drawn any Scheduled Bank in favour of Tamil Nadu Minerals Limited, Chennai.
 - b. Annexure-2 duly filled up and signed.
 - c. Undertaking to the effect that the firm/buyer do not fit into any of the categories mentioned in para 1(b).
 - d. In case the tender document is downloaded through website it should be accompanied by a demand draft of Rs.1,000/- (Rupees one thousand only) / equivalent in U.S Dollar by foreign buyer (Non-refundable) towards the cost of tender document drawn in any scheduled bank in favour of Tamil Nadu Minerals Limited, Chennai 600 005 payable at Chennai.

Cover-I should be superscribed "Cover-I – Technical bid" on the face of the cover and sealed.

ii. **Cover II:** Price Bid – The second sealed cover containing the price / rate quotation as per Annexure - 3 for each quarry material with the name of the tile and put in a separate Cover super scribed as "Cover-II – Price / Rate Quotation" on the face of the cover. This Cover-II will be opened only if the tenderer is qualified to execute the Tender as per Cover - I (Technical Bid).

iii. Covers I & II both sealed separately should be put in a common cover sealed and dropped in the tender box.

iv. If the tenderer fails to comply with any of the above conditions, their offers will be totally rejected.

B. Earnest Money Deposit:

- a. E.M.D. of Rs.50,000/- (Rupees Fifty thousand only) should be submitted by Demand Draft drawn on any Scheduled Bank in favour of Tamil Nadu Minerals Limited, Chennai, payable at Chennai by the foreign and Indian buyers. However, the foreign buyer may remit the E.M.D. in US Dollar equivalent to the Indian rupee value of Rs.50,000/- through any Scheduled Bank and accompany with the tender document.

- b. The tender without EMD will also be summarily rejected.
- c. The Earnest Money Deposit of the unsuccessful tenderers will be arranged to be refunded within a reasonable time, consistent with the rules and regulations of the Company and will bear no interest thereon till date of refund.

14. a. Security Deposit:

Successful tenderers will be required to pay a Security Deposit of Rs. 50,000/- (Rupees Fifty Thousand only) by Demand Draft drawn in favour of "Tamil Nadu Minerals Ltd, Chennai" payable at Chennai, within fifteen days from the date of receipt of communication intimating them of the acceptance of the tender. The sum deposited as Earnest Money Deposit as required in clause 13 B (a) above will be treated as the security deposit. If the successful tenderer fails to execute the sale award, the Earnest Money Deposit already paid by him will be forfeited to the Tamil Nadu Minerals Limited, and his tender will be held void. Both the EMD as well as Security Deposit will bear no interest.

b. Forfeiture of Security Deposit:

If the tenderer fails to act upon the tender or backs out after his tender is accepted his Security deposit remitted will be forfeited by the Tamil Nadu Minerals Limited.

15. Inspection of materials:

- a. The Successful tenderers shall make their own arrangements at their own cost to inspect the materials at the factory itself. All produced shades should be approved by the successful tenderer. In case of any dispute that may arise during selection with regard to cracks, chipping mineral segregation etc. in the tiles, the decision of the officials of the factory shall be final.
- b. Tenderers shall visit Tamin Granites Tiles Plant, Madhepalli and assess the tiles and quote with reference to the materials and it is binding on the tenderers.

16. Shipment / Delivery:

- a. In respect of Export sales shipment will be made by regular Liner Vessels or Chartered vessels by TAMIN. TAMIN shall inform the successful tenderer, the details of shipment after dispatch of Cargo. The extension of shipping period up to three months or more as required by TAMIN shall be allowed. Freight, Insurance shall be made by the buyer to cover against any loss or damage in transit.
- b. In respect of Inland sales, transportation of approved tiles from factory site should be arranged by Inland buyers. In case the tiles are not removed from the factory site within 30 days, the buyer is liable for payment of demurrage charges at the rate fixed by TAMIN from time to time. TAMIN shall not be made responsible for any damage or loss of the tiles beyond the above period.

17. Force Majure Clause:

Delivery is agreed upon in good faith and TAMIN shall not be liable for damage or otherwise for failure to carry out the obligation, which may be occasioned by ACT OF GOD, war, civil disturbances, Disorders, strikes for want of Labour, Act or Regulations of Government Authorities or Agencies, the rulings by the Judicial authorities or similar circumstances beyond their control.

18.Arbitration:

Any dispute or difference whatsoever arising between the parties out of or relating to the construction meaning and operation or effect of this contract or the breach thereof shall be settled by Arbitration, if both parties agree for in accordance with the Arbitration and conciliation Act, 1996 and the Award made in pursuance thereof shall be binding on the parties. The venue of Arbitration shall be Chennai. The language is English only.

19.Judicial Jurisdiction:

The courts situated within the Chennai alone shall have jurisdiction to decide all disputes and claims that may arise between the parties.

20. Assignment:

The Contract is not assignable on either side

21. Insurance:

It shall be the responsibility of the successful foreign tenderer once the materials are put on board the vessel to insure the materials as the rates are accepted on F.O.B. Chennai.

22. Criteria for considering the Tender offers:

The tender will be decided based on: -

- i. Highest rate offered
- ii. Past business relationship with TAMIN
- iii. Market presence of the buyer for the particular variety quoted by him.
- iv. The rate in US Dollar will be converted into rupee value at the rate prevailing on the date of opening of Price bid or date of receipt of currency whichever is beneficial to TAMIN.

When eligibility criteria are equal, preference will be given to direct foreign buyers.

23. Discretion:

TAMIN reserves the right to sell part of its products to others also, in the manner as it likes to the advantage of the Corporation.

The Managing Director, Tamil Nadu Minerals Limited reserves the right of rejection of all or to any of the tenders without assigning any reason thereof or split up the tender as he deems fit.

The Managing Director, TAMIN reserves the right to cancel the bid even after acceptance or during performance of the contract.

The Managing Director reserves the right to alter/modify any of the above tender conditions before the award of the contract in the interest of the Corporation.

General

- i. In the event of any dispute between TAMIN and the successful tenderer, TAMIN reserves its right to stop the supply irrespective of the quantity so far supplied and the matter would be referred to the Indian Arbitration Council and during the said dispute the successful tenderer has no right for the specific performance of the contract nor he will be entitled for damages or any action against TAMIN. The successful tenderer specifically agrees that in respect of any dispute arising out of this contract, he will not pray for any interim order or restraint order against TAMIN in any judicial forum.
- ii. If the successful tenderer has got any trade representative, the said representative will be utilized only for the purpose of trading activity and NOT as the representative of the successful tenderer in the arbitration proceedings or in the court proceedings or in respect of any matter other than the act of mere representative in the inspection of materials and other allied subjects and the said agent will not have any right to represent the tenderer either to commence or to continue or to participate in any dispute or litigation that may arise between the tenderer and TAMIN.
- iii. The agreement on non-judicial stamp paper to the value of not less than Rs.50/- incorporating the above conditions has to be executed by the successful tenderer within fifteen days from the date of sale award issued. The draft agreement will be prepared by TAMIN and sent separately after finalization of the tenders.
